**ESTABLISHING THE ASSESSMENT ROLL OF LOCAL UTILITY DISTRICT NO. 1 OF DOUGLAS COUNTY RIO VISTA PARK STREET LIGHTING SYSTEM FOR THE 2010 ASSESSMENT YEAR AND CALLING FOR NOTICE OF HEARING**

**RECITALS:**

(1) The District did by resolution create Local Utility District No. 1 of Douglas County, Washington, establishing the boundaries thereof and ordering the installation of adequate street lighting within said District; and,


(2) The District did by resolution, with agreement from the City of East Wenatchee, amend the assessment roll to include the City; and,


(3) It has been determined that \$732.00 be assessed against the City, and that \$24.00 be assessed against each lot within said District for the assessment year 2010 and,
